

Dancer in Leach case arrested on misdemeanor warrants

The topless bar dancer embroiled in the DUI case of former Riverside police Chief Russ Leach was arrested Tuesday when deputies came to her Moreno Valley home to serve several misdemeanor arrest warrants.

Michelle Wilson, also known as Michelle Padilla, was booked into jail just before midnight and held in lieu of \$17,500 bail. The warrants relate to violating probation on past convictions of spousal abuse, DUI and driving without insurance and a valid license.

The 34-year-old had recently been locked in a dispute with former Riverside City Councilman Frank Schiavone over their contact following Leach's Feb. 8 drunken drive. Wilson had met Leach while dancing part time at the Club 215 topless bar in Colton.

Wilson has said Schiavone tried to dissuade her cooperation with officers investigating Leach's drinking the club, which preceded his drunken drive. Schiavone, in a report published this week, denied the allegation, saying Wilson was trying to get money from him.
