

AGREEMENT is made and entered into this 8th day of December, 2005, by and between the CITY 7 OF RIVERSIDE, a California charter city and municipal corporation ("City"), and CONNIE H. 8 LEACH ("Consultant") with respect to the following. 9 RECITALS 10 WHEREAS, on or about July 1, 2004, the City and Consultant entered into a Professional 11 Consultant Services Agreement ("Agreement") for a period through April 1, 2005 and extended to 12 December 31, 2005; and 13 WHEREAS, the Professional Services Agreement allows the term to be extended by mutual 14 written consent of the parties; and 15 WHEREAS, the City and Consultant now desire to amend the term of the Agreement from December 31, 2005 through June 30, 2006; and 16 17 WHEREAS, City and Consultant desire to increase the compensation by \$25,000.00 for a total 18 amount of \$50,000.00 for services rendered as defined in Exhibit "A" attached hereto and incorporated 19 herein by reference. 20 NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree 21 to the following amendment to the Agreement: 22 1. Section 3 of the Agreement is hereby amended to extend the term of the Agreement from December 31, 2005 through June 30, 2006. 23 24 2. Section 6 of the Agreement is hereby amended as follows: 25 6. Compensation - Payment. In consideration for the performance of the services set forth 26 in the attached Exhibit "A", City shall pay Consultant \$50.00 per hour for a total amount 27 not to exceed \$50,000.
