

RESOLUTION NO.

1 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
2 RIVERSIDE, CALIFORNIA, SUPPORTING HUMANITARIAN EFFORTS
3 FOR TREATMENT OF ALL INDIVIDUALS INCLUDING RECENT
4 IMMIGRANTS TO THE UNITED STATES.

5 WHEREAS, on September 18, 2001, the City Council adopted a “Building a More Inclusive
6 Riverside Community” statement; and

7 WHEREAS, the statement consists of a set of principles based upon the premises that (1)
8 Riversiders should be and see themselves as respected, contributing members of the community; (2)
9 that all Riversiders should be bound by a common set of principles based on fairness of treatment,
10 recognition of rights, acceptance of responsibilities, commitment to equality, and dedication to
11 expanding opportunities for all; and

12 WHEREAS, this resolution stands in support of the City of Riverside’s long standing culture
13 of embracing diversity; and

14 WHEREAS, the City of Riverside hereby stands in support of sanctuary and humanitarian
15 efforts or assistance in the processing and treatment of all immigrants, including those recently
16 arriving into the United States; and

17 WHEREAS, the Federal Government has an obligation to process these individuals, many of
18 whom are children, and it is in the best interests of all concerned that the ability of the Federal
19 Government to fulfill its responsibilities not be hampered in any way.

20 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that
21 the City of Riverside supports humanitarian efforts for treatment of all individuals including recent
22 immigrants to the United States.
